

## **Abortion Care Network Privacy Policy**

**Effective Date: August 5, 2025**

This Privacy Policy describes how Abortion Care Network (the "Site", "we", "us", or "our") collects, uses, and discloses your personal information when you visit [abortioncarenetwork.org](https://abortioncarenetwork.org) or [keepourclinics.org](https://keepourclinics.org) (the "Site").

By using and accessing the Site, you agree to the collection, use, and disclosure of your information as described in this Privacy Policy. If you disagree with this Privacy Policy, please do not use or access the Site.

We respect your privacy regarding any information we may collect from you across our website and other sites we own and operate. We only ask for personal information that we truly need and collect it with your knowledge and consent.

### **Information We Collect Directly from You**

Information that you directly submit to us through our Services may include:

- Basic contact details including your name, address, phone number, email.
- Donor information including your name, billing address, shipping address, payment confirmation, email address, phone number.
- Information you choose to include in communications with us.

### **Information We Obtain from Third Parties**

We may obtain information about you from third parties, such as:

- When you visit our Site, open or click on emails we send you, or interact with our Services or advertisements, we, or third parties we work with, may automatically collect certain information using online tracking technologies such as pixels, web beacons, software developer kits, third-party libraries, and cookies.

Any information we obtain from third parties will be treated in accordance with this Privacy Policy. We are not responsible or liable for the accuracy of the information provided to us by third parties and are not responsible for any third party's policies or practices.

What data of the above that we store we will protect within commercially acceptable means to prevent loss and theft, as well as unauthorized access, disclosure, copying, use or modification.

### **Information Sharing**

We do not share, sell, or disclose your personal information or mobile opt-in data to third parties without your explicit consent, except where required by law. Your information is kept confidential and used solely for the purposes you have agreed to. All the above categories exclude text messaging originator opt-in data and consent; this information will not be shared with third parties. Text messaging opt-in data is not being shared with third parties.

### **Text Messaging**

Abortion Care Network may communicate with you via text messaging. By providing your phone number and opting in to receive text messages, you consent to the collection and use of your personal information as described in this policy. We ensure that your consent is obtained explicitly and that you are informed about the types of messages you will receive. You have the right to opt out of receiving text messages from Abortion Care Network at any time. To opt out, you can reply "STOP" to any text message you receive from us.

### **Third-party Websites**

Our website may link to external sites that are not operated by us. We do not guarantee and are not responsible for the privacy or security of such sites, including the accuracy, completeness, or reliability of information found on these sites, and cannot accept responsibility or liability for their respective privacy policies.

### **Your Choices**

You are free to refuse our request for your personal information, with the understanding that we may be unable to provide you with some of your desired services.

Your continued use of our Site will be regarded as acceptance of our practices around privacy and personal information. If you have any questions about how we handle user data and personal information, feel free to contact us.

### **Do Not Track**

Our site does respond to Do Not Track (DNT) signals from browsers. Google Site Kit's consent mode and WP Consent API installed, our site respects DNT signals by limiting data collection (e.g., Google Analytics) when users enable DNT.

### **Children's Privacy**

Our services are not directed to individuals under the age of 16. We do not knowingly collect personal information from children under 16. If we become aware that we have inadvertently collected personal information from a child under 16, we will take steps to delete such information.
